Loss of a Loved One

- Have a will or trust created
- Designate a power or attorney
- Inventory your assets
- List all your debt





Disability

- Seek legal advice
- Look into disability assistance:
 - Social Security disability
 - Workers' compensation





Reduced Income

- Look into eligibility for unemployment
- Determine savings amount
- Review your assets










Managing the Transition




